Since Krishna retained your services and then had the Company not only disclose all confidential patent information to you but ordered you the files for the filings, one missed on Saturday and another later this week, we find your about face here to pose serious risk to all the shareholders of Iviewit. As Iviewit allowed Shiffirin & Barroway the right to retain you under our LOU with SB, you must cancel with Krishna whom you arranged your fee deal with, as you are brother-in-laws, I am sure you understand that the Company did not seek and retain your services, SB did.
