Re: International Patent Theft

Dear Jackie Selebi:

We are trying to contact the President of Interpol regarding an international patent theft that is being investigated in several international and US Federal investigations currently under way. The United States Patent and Trademark Office ("USPTO") has issued suspensions on the intellectual properties in question and the EPO has given us your information to contact regarding certain of these matters in relation to frauds committed upon the European Patent Office and the member countries for investigation. Additionally, Director of the USPTO Office of Enrollment and Discipline is personally handling approximately nine complaints against the registered US patent attorneys who have committed the thefts. We are trying to have similar police and agency intervention in Europe to suspend the patents and prosecute the guilty parties, mainly the patent attorneys abroad and freeze all intellectual property assets from further damage.

A private call with the you would be preferred or someone directly referred from you as these matters are of utmost importance in a time sensitive patent case where inventor rights may be permantly lost unless criminal actions can be taken for the criminal activities that have taken place to effecuate such theft of intellectual properties. There are volumes of information regarding the crimes and evidence will be provided once established lines of communication are established. I have attached a list of the crimes and ongoing investigation, in adobe pdf file format, for your review that have already been filed with various authorities.

If this email can be confirmed received it would be appreciated.
