Recently, the Florida Supreme Court unanimously granted <u>Gov. Charlie Crist</u>'s petition to create a statewide grand jury to investigate the corruption of state and local officials as well as judicial misconduct, conspiracy and abuse of power within the Florida legal system. Floridians can only hope that Gov. Crist and Florida Attorney General <u>Bill</u> <u>McCollum</u> will finally begin to restore order.

No wonder the American Tort Reform Association has once again named South Florida the No.1 judicial "hellhole" in the nation.
