Dear Everyone this email was sent and copied to,
I, Eliot Ivan Bernstein, had no idea my name or the names of my companies
Iviewit would be included in the attached letter below and the opinions and
comments in the letter are expressly those of the author, Kevin Hall, Esq.
I personally had no input of any kind in this letter and while Kevin Hall
is a business consultant to me on occasion, he has no authority to speak
for me or my companies without my express knowledge and consent. In
particular, the innuendos about Kevin McKeown/Frank Brady are in no way how I feel
about Kevin, I think his work has been solid, exposing corruption in New
York and bringing about, albeit slow, change. Kevin has aided and protected
Christine Anderson, a former NY Supreme Court Staff Attorney
Whistleblower, in bringing forth her riveting allegations of Public Office
Corruptions
before the NY Senate Judiciary Committee and under sworn oath in a Federal
Court. Testimony that fingered US Attorneys, DA's, ADA's and the New York
Attorney General Andrew Cuomo in Federal and State Crimes, including
violations of Title 18 and Anderson again made these allegations in sworn

statements in open federal court and in her testimony before the NY Senate Judiciary Committee. Anderson then notifying federal and state criminal authorities of these crimes, raising the crimes to the attention of the highest persons in our system of Jurisprudence, including US AG Holder, in her HEROIC Whistleblowing efforts. I have attached Anderson's written statement to leading US law enforcement below my email and prior to Mr. Halls attached email.

Efforts that have led to physical assaults on Anderson to hush hush the crimes or else and to another staff attorney of the New York Supreme Court, Nicole Corrado, who also came forward to support Anderson's claims and alleging that she was also threatened and extorted on her way to testify for Anderson by Senior Court Officials of the New York Supreme Court. Kevin also aided Anderson in filing her Whistleblowing Lawsuit and helped many others become legally "related" to the Anderson suit by Fed Judge Shira Scheindlin. Kevin also brought many victims into the federal courts with their complaints, giving them great opportunities to litigate at some point their cases in a Federal Court. Kevin also claimed that he would get a NY Senate Judiciary Committee investigation going (supplementing my own efforts already under investigation at the House and Senate Judiciary Committees) and his success has led me personally to testify before the Committee and allowed me to submit voluminous amounts of evidentiary materials to that Committee, which remains investigating the matters of Widespread Judicial and Prosecutorial corruptions exposed by Anderson, myself and many other victims of the

corrupt New York Courts. Kevin has also provided a blog <http://exposecorruptcourts.blogspot.com> (<http://exposecorruptcourts.blogspot.com/>)

that has led to a community for victims to voice their concerns, present their cases and get involved in something, whereas before they may have felt deflated, depressed or otherwise suicidal from the effects of having their properties stolen by lawyers and judges who are running a Criminal RICO Enterprise within the New York courts, a feeling of helplessness when there are no public officials to complain to, as Anderson shows, they all appear in on the crimes.

I also have no information regarding Sunny Sheu, his life, his lawsuits or his purported death (as I have no physical evidence of such death) and any statements made by Mr. Hall are his own and again I had no input nor comment on his letter prior to his sending it to my friends, clients and investigators handling the Iviewit and Eliot Bernstein investigations. I state here that while I am not claiming one way or another that Mr. Sheu is dead, if he is, I have no opinion of if foul play were involved or not and am awaiting physical evidence. With Anderson and Corrado's statements of extortion and threats by COURT OFFICIALS on Whistleblowers and witnesses in a Federal Lawsuit, I do fear that Mr. Sheu may have met with foul play, in fact, after the car bombing of my families minivan in efforts to murder my wife, my three children and myself, I certainly understand others fear. Please take this letter and correspondences attached and make this a part of my ongoing investigations with those parties sent this communiqué who have Iviewit or Eliot Bernstein complaints open. I understand Mr. Hall's impatience in wishing justice to happen overnight for the victims but after learning from Anderson and others the level of corruption within the courts, the ethics

departments, the state and federal prosecutorial offices, the regulators offices, etc., it is apparent this may be one of the largest scale crimes ever committed against our government, a coup d'état in fact and as such, action may take longer than one wishes for. I look to Federal operations such as Operation Greylord in Illinois or the Tammany Hall corruptions and know that patience and time are required to bring down a treasonous criminal RICO Enterprise of this size, that has seized control of major government agencies, politicizing even the Justice Department and more and restore justice to those victims who have been treaded on. On the other hand, I have witnessed many corruptions of federal and state agencies in my Iviewit Patentgate matters and so all of these concerns of victims that their complaints are being buried or derailed may be factually correct but simultaneously there are many ongoing investigations by dedicated and loyal to our country investigators whereby I have nothing but Kudos for their efforts on my behalf thus far.

RE: Request for Federal Investigation Into Allegations of Corruption and Witness Intimidation and Appointment of Federal Monitor

Gentlemen:

My name is Christine C. Anderson. For six and one-half years, I was a Principal Attorney of the New York State Appellate Division, First Department's Departmental Disciplinary Committee (the "DDC"). The DDC is responsible for investigating and disciplining attorneys found guilty of misconduct in representing the public in the Bronx and Manhattan. After discovering and reporting of acts of misconduct and corruption at the DDC, which acts constituted an abuse of power and a fraud upon the public, my employment was summarily terminated in June, 2007.

Prior to my employment with the DDC, I was in private practice for over twenty years. Before that, I worked for the Human Resources Administration of New York City. In other words, I am a thoroughly seasoned attorney, with a broad based knowledge of general practice.

As a result of my wrongful termination in retaliation for my reporting

misconduct in violation of my First Amendment rights, I instituted a lawsuit captioned Anderson v. State of New York, et al., 07 Civ. 9599 (S.D.N.Y. 2007). (A copy of my complaint in this action is attached hereto as Exhibit A.) Specifically, I discovered and reported that employees of the DDC had engaged in, inter alia, the "whitewashing" [of] complaints of misconduct leveled against certain "select" attorneys and law firms. This "whitewashing" sometimes involved burying cases or destroying evidence, so that certain complaints were inevitably, unavoidably, dismissed. I witnessed this destruction of evidence myself. Other reported misconduct involves victimizing attorneys lacking privileged positions or connections.

Although the then Chief Counsel of the DDC, Thomas Cahill, stepped down in 2007, evidence clearly establishes that under the leadership of Alan Friedberg, the current Chief Counsel, the same practice of corruption and whitewashing of complaints continues. Such practice robs the public of any hope at justice; it also works to the detriment of the very public the DDC is duty-bound to serve.

During the course of my litigation against the DDC, a former colleague of mine, who still works as a Principal Attorney at the DDC, agreed to testify on my behalf at a deposition. This former colleague, Nicole Corrado, has been employed by the DDC for approximately eight years, prior to which she worked as a prosecutor for New York State. On the morning of her deposition, however, while en route to her deposition, Ms. Corrado was approached on the street by a supervisor at the DDC, who threatened and intimidated her with respect to her upcoming deposition testimony. Although terribly shaken, Ms. Corrado nonetheless sat for her deposition and testified truthfully. Following her deposition, however, Ms. Corrado has been subjected to further harassment and intimidation at the hands of the DDC. She has been forced to take a leave of absence as a result.

On June 8, 2009, I testified at a hearing convened by John L. Sampson, New York State Senator and Chairman of the New York State Standing Committee On The Judiciary. (A copy of my affidavit submitted to the Committee is attached hereto as Exhibit B.) At that hearing, several witnesses testified as to their shocking experiences with the grievance and judiciary committees in New York State. Shockingly, within days of my testimony, in my lawsuit, my sealed medical and psychiatric records were filed and posted publicly on the court's Internet filing system by counsel for the defendants - i.e., the New York State Attorney General's Office. I regard those actions as horrifically unethical and malicious, and taken in deliberate retaliation for my testifying at the Senate hearing.

The detailed testimony presented by innumerable witnesses at the June 8th Senate hearing reveals the manifold reports of corruption and abuse by the State's Disciplinary Committees. (A copy of the transcript of this hearing is attached hereto as Exhibit C.) Charges included concealment of evidence, obstruction of justice, extortionate sexual threats by attorneys, pilfering of estates by attorneys, abuse of power, fraud, conspiracy and repeated violations of state and federal constitutional rights.

In light of the foregoing, it is plain that the enduring practice of allowing attorneys in this state to police themselves is fundamentally flawed. With the numerous reports of abuse by both attorneys and state officials, the corruption in the court system has reached a critical stage. Accordingly, I respectfully request that you authorize the appointment of a Special

Prosecutor to investigate the epidemic of honest services fraud in the New York state court system, and the appointment of a Federal Monitor, to oversee the lawful operation of the same.

Thank you for your time and attention. I look forward to your response.

Dear Ranking Members:

As a resident of Upstate New York who has studied government, worked in State government, and been involved the last several years with a Group of Citizens trying to correct rampant corruption within the State of New York, and perhaps the Federal government within the State of New York, I now forward the following email as an Urgent matter based upon a Recent Suspicious Death of one Sun-Ming "Sunny" Sheu of Queens County, New York just days after Mr. Sheu obtained updated information on the Ethics / Judicial Disclosures of one State Supreme Court Judge Josphe Golia of Queens, NY. The substance of the forwarded email implicates operations of the US DOJ, FBI, and other government actors as well and many of these entities have been copied already. This letter should also serve to Follow Up a letter from attorney Eleanor Capogrosso sent to Congressmn Edolphus Towns of the House Committee on July 9, 2010 a copy of which has been copied and pasted below. Attorney Capogrosso, not only a victim locked out of her office due to the World Trade Center Bombing, but also has received Death threat for going to the US Attorney in New Jersey.

I first note for the Committee that through my personal political activities, I have had occasion to meet in person Senator Carl Levin at an event for US Senator Barbara Boxer at the Spy Museum in Washington, DC in Jan. of 2005 while also meeting then House Member Jane Harmon and then House Member Nancy Pelosi (prior to becoming Speaker) on the same occasion. I have also met US Senators Maria Cantwell, Senator Feinstein, Senator Lincoln, Senator Mikulski, Senator Murray, Senator Stabenow at an event in NYC in 2002 with then US Senator Clinton and have met other elected officials in my years.having previously worked in the Governor Cuomo Administration in NY back in the early 1990s as an Environmental attorney.

As this Committee will note in the email below, My Personal Cell Phone was Interfered with on 3 separate occasions during the morning of June 27, 2010 while speaking with FBI Supervising Special Agent Rachel Rojas of the FBI Mortgage Fraud Unit Squad C3 about the Sudden Death of Sunny Sheu as Agent Rojas had warned Sunny to "be careful" in the weeks before his death. Upon information and belief, shortly after my Calls with Special Agent Rojas that morning of June 27, 2010, several NYPD Officers went to the NY Hospital Queens NY and removed Sunny's body from the Hospital despite a prior conversation by myself the night before with NYPD 109th Precinct Detective Austin who claimed that the death was "Not a Police Matter". Since the morning of June 27, 2010, multiple stories about how Sunny was found and how he died have emerged while NO Release of any 911 Calls, EMT Reports or Police Reports have emerged yet. As the Committee will note from the email below, Sunny Sheu had been fighting Mortgage Fraud Corruption in Queens, NY for nearly 10 years and was now obtaining critical information on Financial Disclosures from the involved Judge showing undislosed real estate and construction interests.

This email below goes on to detail some of the actions of one "Kevin Mc Keown" also known and presented originally to myself as one "Frank Brady". Frank Brady claimed to me in late 2007 that he had previously done at least "Contract" work for the US Postal Inspectors Office, US IRS, US DOJ, and other agencies potentially including the NSA and/or CIA. Frank Brady claimed

that ongoing investigations into Wall Street fraud and corruption were tied in to corruption at the NYS First Department Appellate Division and Discipline Committee in Manhattan and that investigations into all 4 NYS Appellate Divisions and the State Commission on Judicial Conduct were ongoing. Frank Brady has a blog known as www.exposecorruptcourts.blogspot.com which features an Article alleging that an International Espionage criminal ring was tied in to Wire and Email intercepts and directly connected to the corruption at the NYS First Dept DDC. As a US Citizen it is quite troubling that 3 separate Interferences with my Personal Phone Call to a Supervising FBI Agent occurred and shortly after NYPD Agents take the Body of Sunny Sheu out of the Hospital BEFORE any Death Certificate had been signed despite Detective Austin the night before claiming this was Not a Police matter. Of course, I find ANY interference, Wiretapping and eavesdropping of personal communications to be violative of federal law and US Constitutional standards and maintain an ongoing Objection and do not consent to same.

A search of Kevin McKeown (aka Frank Brady) in the Federal Courts PACER system will show multiple cases around the nation and also maintaining an Address at the Whitehouse at 1600 Pennsylvania Ave, etc. I met Sunny Sheu as a result of the efforts of Kevin McKeown / Frank Brady who gathered multiple individuals around New York state to expose and correct widespread corruption. By the time I came in to contact with Mr. Sheu, I had been introduced to one Eliot I. Bernstein of Boca Raton, Florida, an Inventor who suffered an Attempted Murder on his life via a Car Bombing in Boynton Beach after Mr. Bernstein invented Technologies used by the DOD, Lockheed Martin, Intel, and a host of other uses including internet video, the Hubble Space Telescope and more. Full pictorial evidence of the Car Bombing against Mr. Bernstein can be found at www.iviewit.tv where this Committee can find Formal Petition to President Obama, then White House Counsel Craig, and US AG Eric Holder due to the Theft of his Trillion Dollar plus inventions and Fraud upon the US Patent Office also allegedly investigated by the FBI and US DOJ and US PTO and others.

Mr. Bernstein's case had been marked legally "related" to a Federal Whistleblower case of Attorney Christine Anderson who worked at the NYS First Department DDC and the marking of several cases as legally "related" to Anderson was performed by US District Judge Shira Scheindlin. I can submit at a later time the Index Numbers of these cases but this information can also be found at www.iviewit.tv.

As you will see by the email below, however, many folks who have come in to contact with Kevin Mc Keown / Frank Brady have had their cases go in to the "Black hole" while Mr. McKeown Promised individuals like one Jackie Weaver and John Turner that Federal Agents would be in touch to investigate yet it is over a year now and Not only NO Investigators have shown up, but folks who continue to try and GRIEVE their government face Threats, Intercepted Calls and emails, and now the DEATH of Sun Ming "Sunny" Sheu. This is not to say this is caused by the actions of Mr. McKeown / Frank Brady but

only to show the pattern and circumstances that have emerged. Virtually all citizens that I know involved in trying to change the corruption in New York have already gone to ALL State level bodies such as NYS Attorney General, NYS Courts, NYS Commission on Judicial Conduct, to no avail and in fact often face further retaliation.

I respectfully submit that the matters herein in New York have reached the level where Congressional action must occur to put a spotlight on the Federal Agencies operating in New York. Citizens were repeatedly told for over a year and a half that a "Special Prosecutor" from Washington, DC would be forthcoming and no such thing has occurred. Citizens are now living in fear of reporting any wrongdoing based upon the Sunny Sheu death.

Another situation in New York involves a local Minority individual in upstate NY who has tried to get the Washington, DC FBI Field Office involved in New York matters after repeated disregard by the Albany, NY FBI as well. This situation alleges the murder of at least one if not several minorities in the Upstate NY area claimed to be "suicide" and while the matters are many years old at this time, the Multi-racial individual trying to uncover the truth has faced serious retaliation, tampering with his car, cable system and more and yet calls to federal authorities go unanswered and/or unreturned on most occasions.

I look forward to hearing from your Committee soon and am available by phone and to submit further documentation as well.

Dear Mr. Stroman,

I just spoke to Yolanda Nicholsan of Congressman Edolphus Towns' Brooklyn office, and she advised me to contact you directly. I am writing regarding the necessary oversight by your committee of the New York FBI and the Department of Justice and how they are handling the issues of state and federal court corruption in this state. I sent a fax to the Committee on Oversight and Government Reform dated 5/18/10, attached hereto. Here I only included the first page of "Expose Corrupt Courts," but in the original fax I included it in its entirety. In this fax I attached a letter that I sent to all members of the judiciary committees of the House and Senate as well as the Attorney General and Director of the FBI. The gist of the matter had to deal with the FBI covertly organizing an effort among citizens to gain tips of the corruption within the New York Court system. As you can read from my letter to John Chastain, General Counsel for the Courts, the corruption has bled into the federal courts as well. Now a man is dead. Sunny Sheu was involved in a Mortgage Fraud Battle, where he thought that his home was stolen due to the judicial bias of Judge Golia. The video was released after his death, on June 26, 2010. It is my understanding that Sunny Sheu received an email from the FBI telling him to be careful, and shortly thereafter he was found dead.
