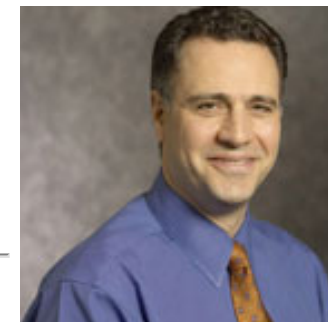

From 1983-1989, Mr. Krantz served as an Assistant United States Attorney in the Criminal Division of the Eastern District of New York, where he successfully prosecuted cases involving financial fraud, arms-export violations, tax evasion, bribery, organized crime and narcotics trafficking.. He was also formerly a partner at Leventhal Slade & Krantz, an associate at Proskauer Rose LLP and an Adjunct Instructor of Legal Writing for Brooklyn Law School.

Mr. Krantz is a Director of the New York Council of Defense Lawyers (www.nycdl.org), a Member of the Joint Local Rules Committee for the Southern and Eastern Districts of New York and a Member and Master of the Federal Bar Council Inn of Court. Mr. Krantz regularly teaches trial advocacy for the American College of Trial Lawyers and is a chapter author of the treatise "Defending Federal Criminal Cases: Attacking the Government's Proof" (Law Journal Press).
