Federal Judge Considers Re-Opening One NY Corruption Case

Judge Scheindlin Sets Briefing Schedule in Move to Re-Open Esposito Case

September 9, 2011

FROM THE CASE DOCKET: "ORDER: It is hereby ordered that defendant Isaac file and serve his opposition to Plaintiff's Motion by September 17, 2010, or shortly thereafter with leave of the Court. Furthermore, it is ORDERED that counsel for defendant Isaac confirm that all co-counsel have a copy of this Order as well as Plaintiff's Motion. Should any other defendants wish to oppose plaintiff's Motion, they too must file and serve their opposition papers by September 17, 2010. (Signed by Judge Shira A. Scheindlin on 9/8/2010) (jpo) (Entered: 09/09/2010)"


U.S. Federal District Court Judge Shira A. Scheindlin has accepted a motion to re-open one of the related cases in the New York State Attorney Ethics Scandal. Judge Scheindlin had previously approved the-then third related case in the New York ethics scandal in January of 2008. (*Esposito v. The State of New York*, SDNY 07cv11612) The September 8, 2010 dated Order gives the defendants until September 17th to file any

opposition papers.

The Esposito case had joined the *Anderson v. The State of New York* matter now under appeal with the 2nd Circuit Court of Appeals. Judge Scheindlin ultimately dismissed all of the related cases that had exposed the long-held practice of cover-ups and whitewashing of complaints against favored attorneys at the Manhattan based attorney Departmental Disciplinary Committee. The original Esposito filing followed the January 11, 2008 announcement that the 1.5 Billion dollar Iviewit lawsuit, known throughout the world in technical, intellectual property circles as "Patentgate," had been accepted by Judge Scheindlin as related to the other Attorney Ethics Scandal filings. (*SDNY Bernstein v. Appellate Division First Department Departmental Disciplinary Committee*)
