AFFIRMATION OF PAMELA CARVEL

I, PAMELA CARVEL, state as follows:

- 1. I am over eighteen years of age and competent to testify to the facts and matters set forth in this Affirmation.
- 2. I am a member of the Association of Certified Fraud Examiners. I have acted as fiduciary and guardian in charge of litigation in Thomas and Agnes Carvel's estates, trusts, corporations, and charities.
- 3. I make this Affirmation in support of the application to appoint a Federal Monitor over the Commission for Judicial Conduct and the Disciplinary/Grievance Committees for New York City and Westchester County.
- 4. If not for unbridled corruption I would not have been defrauded, my family's life's work would not have been destroyed, society would not have been harmed, and lethal blows to the fabric of our democracy would not continue to be launched unchecked.
- 5. My family and I were harmed materially by forgery, political corruption, theft, and apparent murder with the intent of stealing over \$350 million of Carvel assets (also see 08-cv-03305-SAS). Attorneys blithely committed crimes and ethical breaches outlined in the New York Law Journal. Such blatant violations were ignored and accepted by all "officers of the court" and agencies who knew about these violations.
- 6. More significantly to the People of the State of New York, the basic fabric of our Constitution is shredded by apparent political bribery and judicial patronage to select "friends"

of the court. Issues requiring recusal or disqualification are ignored in Westchester although

investigations indicate that lesser instances in other jurisdictions resulted in the removal of

judges. The court violates the equal rights guaranteed all Citizens by denying indemnification of

administrative expenses and legal fees to all fiduciaries equally. The court denies due process to

successfully silence all opposition by withholding from objecting fiduciaries all funds needed for

legal fees, and by denying the elder or ill fiduciary-beneficiary funds needed for life itself in a

form of extortion to silence objections to victimization and outright thefts.

7. Property from estates, trusts, charities and the deceased's businesses disappear

without court order, without accountability, often directed into the hands of employees or

"friends" of the court. Investigations clearly document fraudulent conveyances without notice to

creditors, beneficiaries, or assets owners, with under-valued prices and self-dealing.

8. If proper ethics oversight were in place Westchester Surrogate Anthony Scarpino

and his court would be stopped from looting numerous estates that I investigated thus far. There

would be a statewide investigation that would have revealed the crimes against the People

discovered in Brooklyn as being systemic in the Southern District. The goons and thugs would

not feel so empowered by the abuse of their public office to tweak the system to their own

private and individual profit.

I declared under penalty of perjury that to the best of my knowledge the facts and matters

set forth above are true and correct to the best of my ability.
