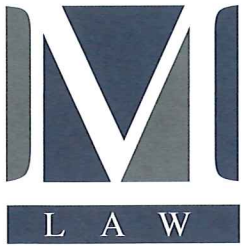

Dear Judge Coates:

Our law firm represents Ted S. Bernstein, as a Successor PR and as a Successor Trustee, in the above matters, including two estates and two trust matters assigned to this Division after Judge Colin recused himself last week. We are not suggesting that the Court take any particular action, but simply bring these matters to your attention so you may consider this matter.
