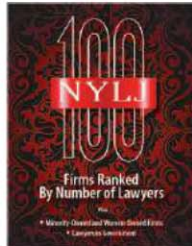

EDITOR'S NOTE

With the coming of a new season comes another edition of the NYLJ 100, where we once again present firms' average number of full-time equivalent attorneys in New York state for the preceding calendar year (Jan. 1 to Dec. 31, 2014). For firms with multiple locations in the state, we combine the offices' individual headcounts to arrive at one total, statewide number of attorneys.

This special report also contains charts listing attorney headcounts for the largest minority-owned and women-owned law

firms in New York state, as well as the figures for each of New York's 62 district attorney offices, the attorney general's office, the New York City Law Department, and the state's four U.S. attorney offices. Unless otherwise noted, all numbers are as of Dec. 31, 2014.

Using data obtained from the Office of Court Administration and the U.S. Census Bureau, we also include a chart of attorney concentration by county, illustrated via a ratio of attorneys to general population for each county in New York.

Production of the entire NYLJ 100 issue

requires a large amount of numbers, data reporting and checking, data entry and proofreading. Gains Exceed Losses at Firms Statewide, While Public Sector Head Counts Remain Steady

After years of post-recession stagnant or shrinking head counts, New York state's largest 100 law firms showed solid growth in 2014.

The total number of full-time lawyers in the private sector's 100 largest firms, about 21,500 total, grew 2 percent last year, with gains spread across the New York City multinationals as well as the statewide regionals.

Six of the top 10 New York City-based mega-firms showed strong growth, with the first and second largest, Paul, Weiss, Rifkind, Wharton & Garrison, and Simpson Thacher & Bartlett, recording 9 and 13 percent gains, respectively. Paul Weiss ended the year with 778 full-time attorneys up from 716, and Simpson rose to 626 from 553.

Skadden, Arps, Slate, Meagher & Flom dropped out of 2013's number two slot, to number three, as its head count fell 1 percent, from 629 to 620.

Davis Polk & Wardwell, with 589 New York-based attorneys, recorded a 5 percent gain to 589 from 562.

"In each of the last several years we have experienced high single digit percentage growth in demand for our services," said Thomas Reid, managing partner at Davis Polk. "Our lawyer productivity, which was already in excess of 1,900 hours, still increased by 2 percent in 2014."

The largest growth in lawyer head count not attributable to a merger was registered by London-based Freshfields Bruckhaus Deringer, with a 19 percent jump to 157 from 132 last year.

Freshfields is the fourth largest firm globally, and the largest in Europe and the United Kingdom.

Adam Siegel, managing partner for the U.S. at Freshfields, said "this is the right moment to grow the transactional side of our practice as we grew litigation in our earlier years."

"We needed to expand in project finance, capital markets and mergers and acquisitions in order to provide the seamless cross-border service Freshfields aims to deliver," said Siegel.

The firm, now ranked number 57, is up nearly 10 slots from a year ago.

Siegel said the firm had brought in 22 summer associates for its U.S. offices this year, and that "we see no slacking of demand."

"As long as interest rates stay low, we think the mergers and acquisitions market will expand," said Siegel. "Valuations in Europe remain very attractive for U.S.-based purchasers," he added.

As a result of its absorption of 225 partners from the now-defunct Bingham McCutchen last year, number 24-ranked Morgan, Lewis & Bockius had the biggest gain in lawyer headcount, a 51 percent increase to 274 from 181.

The biggest drop on the NYLJ tables was recorded by Kelley Drye & Warren, with a 12 percent shrinkage in its ranks to 116 from 132.

The reductions were due to the "trimming of unproductive partners," said the firm's managing partner, Lewis Rose.

As a result, Rose said, firm revenues were up 5 percent, and profits were up 9 percent for 2014.

"We owe it to the productive partners, and the new people coming on board, to have a lean and mean firm," Rose said.

About 15 partners left the firm in 2014 and the first quarter of 2015, Rose said. "We expect the trimming will continue this year."

Five new partners were named last year, "and we expect about six more this June," said Rose.

A State of Growth

Growth was also evident among the statewide firms based outside of New York City.

Syracuse-based Bond, Schoeneck & King posted a 16 percent gain, growing to 211 lawyers from 182. "We have rounded out our presence in our satellite offices," said Rich Hole, chairman of the firm's management committee.

"We brought on nine first years," said Hole. "We intend to grow organically in all of our practice areas—health care, education, creditor's rights."

Hole said the firm had "come through the recession just fine. We did not have any layoffs." He said the firm intended to expand in the intellectual property area in the coming months.

Buffalo-based insurance defense firm Goldberg Segalla was representative of growth trends among New York-based regionals, with

a 9 percent expansion in New York last year, to 145 lawyers from 133.

"We've grown from seven lawyers to 240 in the Eastern U.S. in 14 years," said managing partner Richard Cohen. The firm represents defendants in products liability, professional malpractice and personal injury cases.

"It has been a straight line upwards," said Cohen, "and the trend has not slowed. We've grown both upstate and downstate."

The firm has 14 offices in seven states, with its largest presence, about 100 lawyers, in the New York City area.

Legal recruiting companies reported expansion as well.

"Law firms realize they have to start getting the best people on board before the demand hits," said Michael Reichwald, president of Yorkson Legal, a staffing and recruiting firm.

"Firms are telling us they may have pulled back a little too much," said Reichwald.

"The demand right now is strongest in real estate," he said, noting that his business was up 30 percent over last year. "Litigation has quieted down a bit."

Reichwald said that most of the placements in 2013 were in firms, but in 2014 a trend toward in-house hiring picked up, and currently about half of full-time hires are in-house.

"We are now seeing demand that exceeds the pre-recession levels," said Reichwald.

Government Offices

Staffing levels in the largest public sector legal employers has remained constant. The New York City Law Department had 754 lawyers, about the same as 2013.

The New York State Attorney General's Office experienced modest 3 percent growth. Similar increases were reported by the state's four federal prosecutor's offices, except for the Eastern District, which saw a 10 percent jump to 174 from 158.

Most county district attorney's offices did not see major changes in staffing levels, except New York County, which under District Attorney Cyrus Vance has cut its head count by 11 percent to 486 from 549.

Minority and women's representation among the public sector employers was largely unchanged.

Our Methodology

The NYLJ 100 ranks the 100 largest firms by number of lawyers in the state of New York. (Attorney numbers for the public law offices of the Corporation Counsel, attorney general and U.S. and district attorneys are listed in separate charts.) Every private law office in the state is considered, irrespective of where the firm is headquartered or whether it claims a home office. Non-U.S.-based law firms are considered equally with domestic U.S. firms; the sole criterion for inclusion in the NYLJ 100 is the size of a firm's New York state presence.

Law offices are ranked by the total number of permanent, full-time-equivalent attorneys (partners plus associates plus "other attorneys"—staff attorneys, of counsel, etc.); where a firm has more than one office in New York state, the attorney totals for each office are added together to arrive at one statewide total. In the case of a tie between or among firms, they are ranked equally but listed alphabetically. Firms' branch office totals are also listed; where a firm indicated that a branch office had zero attorneys in 2014, the branch was omitted from the list.

The NYLJ 100 is prepared from two primary sources: data obtained through the 2015 NLJ 350 survey conducted by The National Law Journal, an affiliate of the New York Law Journal, and the New York Law Journal's own 2015 NYLJ 100 survey. All data are average full-time equivalent numbers for the period from Jan. 1 through Dec. 31, 2014. Lawyer counts do not include contract or temporary attorneys.

Because attorney numbers are submitted in full-time equivalent terms, in some cases, due

to rounding, numbers are slightly higher or lower than the figures submitted by the firms. Additionally, minor discrepancies between the total number of attorneys at a firm and the total number reported in branch offices are due to rounding. If the New York Law Journal received corrected or updated numbers from any firm surveyed by The National Law Journal, the corrected or updated numbers are used here. Figures for firms that choose not to respond to the survey are estimated based on the firm's website.
