**Statement of Complaint (continued):**

I, Skender Hoti filed a complaint with the department on 5/1/16 and nothing has been done to date to the best of my knowledge regarding the complaint. I discovered in approximately Feb 2017 that the case had been mis-docketed and nothing was done on it allegedly because my name was improperly entered into the computer system at PBSO. I sent in a correction form to Marsha A. Tookes who then referred me to Sgt. Jezewski in District 1. I contacted Jezewski and once the complaint corrected it was supposed to be investigated. Recently, I contacted PBSO dispatcher named April in 2018 and she stated that the case was open and she would get back to me within a day. As of this date, April has not contacted me to inform me of the status of the investigation. In March 2018 I contacted Internal Affairs and spoke with Officer Morrisson to try and determine what the status of the case is and why nothing has been done to date and he had me pick up an IA form to fill out. At this time I believe that this case and my prior cases to that relate to this case have all been mishandled by the PBSO with intent in efforts to protect Judge Martin Colin and others. The case listed above also involves the following cases that I would like made part of this IA investigation.

My case has gained national media attention and I believe that my criminal complaints are being suppressed due to the fact that they are against a former PB Civil Judge Martin Colin and his wife Elizabeth Savitt Colin along with attorney/guardian Sheri Hazelton. See PB Post Article

I have been trying to get investigations into these matters for years with PBSO and every time my complaints are mishandled, no one is contacted, the FOIA I receive shows nothing is being done and no one has been assigned. These complaints center around the alleged murder of my mother and theft of our family's assets by parties who may have strong connections into PBSO through their legal connections. I would like IA to review this complaint and determine what has happened to the complaints and if they have been purposefully derailed and if so by whom.

I would like to make sure that no officer investigating these matters has any conflicts of interest with Judge Colin or anyone else I have complained about before any determinations are made.
