**Beneficiary's Petition for Disbursement from the
Court Registry to the Beneficiary**

With all due respect to the Court under penalties of perjury, Beneficiary Joshua Ennio Zander Bernstein ("Joshua") as the Petitioner respectfully petitions the Court to please order disbursement of amounts deposited into the Court Registry for his benefit pursuant to the Court's December 6, 2017 Order.

1 The Order directed Petitioner Ted S. Bernstein (“Ted”) to make direct payment into the Court Registry for the benefit of the children of Eliot I Bernstein (“Eliot”).

2 In support of his Petition, Joshua states that Joshua, born 08 27.1997 (Exhibit A), is now 21 and resides at 2753 NW 34th St Boca Raton, FL 33434.

3 Joshua files and serves his Petition as *Pro Se Attorney-in-Fact*, *does not need* any legal representations by any licensed attorney at law, did not retain for any legal representation by the NY Attorney Lalit K Jain Esq of 6122 Booth Street, Rego Park NY 113741034 (“LKJESQ”), has *full trust, faith and belief* in LKJESQ to be his personal attorney, like a life-coach, to help him understand whatever needs to be understood in his own best personal interests to financially manage his life properly, knowing that Attorney Jain is a Chartered Accountant from India and an Attorney at Law duly licensed to practice law in New York, Federal Courts, the Supreme Court of the United States (“SCOTUS”) and in India too for over 30 years.

4 A total sum of \$ 146,751.12 (“Funds”) for the benefit of Joshua has been duly deposited into the Court Registry as follows:

- .1 \$ 129,751.12 (\$ 60,000.00 and \$ 69,751.12) on August 1, 2018 (Exhibit B); and
- .2 \$ 17,000.00 on October 31, 2018 (Exhibit C).

5 Joshua, at least eighteen years of age, is entitled by law to the release of the Funds for his own personal use in accordance with the provisions of Court-Approved legal documents which, amongst others, state that the Funds are to be used for his Education, Needs and Welfare, etc. as duly explained in paragraphs 4 and 5 on page 6 of the Simon L Bernstein Amended and Restated Trust Agreement. Joshua is in urgent need of these funds on a timely basis *but for which* he will be forced to be in default on timely payment of his college tuition, housing and many other bills he has amassed and will keep amassing. As the money requested had no opposition on 12/11/18, so the Court is required by laws correctly applied to immediately release the funds to

end his ongoing daily damages that include, but are not limited to, his *non-moneymaking* activities of daily living ("ADL") which, manifestly, will permanently hurt his *moneymaking* ADL.

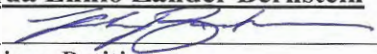

7 There are no other claims to the Funds other than this claim by the Petitioner.

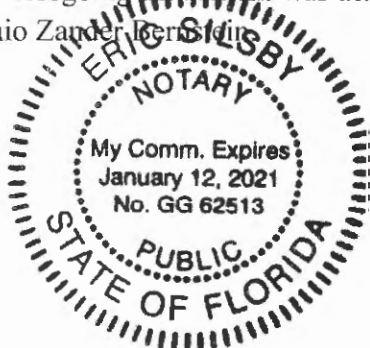

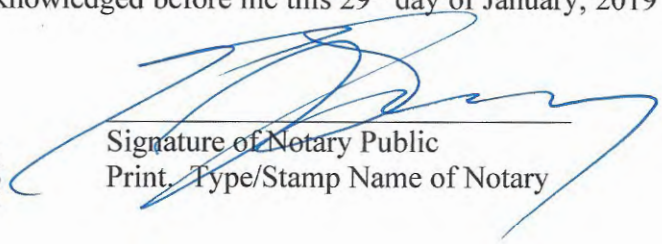
