**EMERGENCY MOTION FOR DISBURSEMENT FROM COURT REGISTRY**

That Joshua Bernstein Pro Se so states,

1. On 08/30/2018 332 I filed a Motion for Disbursement Docket Entry 332.
2. On 12/11/2018 I filed a Second Motion for Disbursement Docket Entry 348.
3. That on 02/11/2019 the Court Sua Sponte, that too, with no opposition to the Motions, filed an Order delaying the hearing on the matters until 7/24/19 @ 9:30 AM.
4. That on January 18, 2019 I was injured in a multi car accident on I-95 in Florida and diagnosed with whiplash. I was rear-ended multiple times. I was prescribed medicines and physical rehabilitation which continue to this day. The accident was deemed no fault of mine.
5. I had to make the Court aware of the extreme and urgent need for the funds due to the accident.
6. The insurance company “totaled” my car leaving me without a car.
7. I have contacted the parties involved in these court matters regarding my emergency needs for a new car, insurance for that car and a small amount to pay off a credit card balance of under \$2,000 that has accumulated since I have become partially disabled and sought to have the funds held in my name in the Court Registry released through an Agreed Order that Your Honor deemed would suffice to release funds.
8. Without a car, I cannot go to school or my job timely and this is depriving me of daily activities of living (“ADL”).

**9.** The only party objecting is my uncle, Ted Bernstein, who is acting as a fiduciary in this matter to beneficiaries such as myself and his counsel, Alan B. Rose, Esq. (see Exhibit 1, Emails regarding Disbursements to Fiduciaries).

**10.** Their objections are primarily sending monies for needs to my Life Coach and friend, Attorney at Law, Lalit K. Jain, Esq. who has a decades long career in law and accounting and whose ethics are beyond reproach and in fact teaches me about their importance for the sanctity of the Courts.

**11.** As the Court ordered that an agreed Order would suffice to address the issues for disbursement in my filed Motions, I have provided my uncle and his counsel with an alternative solution that would resolve their concerns but they have refused to even comment timely, knowing the emergencies and crises this is causing me.

**12.** So I am forced to waste the Court's time and everyone's time involved with this fairly simple request that could have easily been resolved by sane parties as the fiduciary acting on my behalf who refuses to help without Court help.

WHEREFORE, I request this Court to please ISSUE AN ORDER DISBURSING THE FUNDS OR SET AN IMMEDIATE HEARING TO NOT FURTHER WASTE ANYONE'S TIME.

Dear Mr. Rose,

Due to no fault of mine, I was rear-ended, injured and my car totaled in a January 18, 2019 auto accident.

I am in immediate need of a car for work and school.

I attach a copy of the Jeep car I picked out and the insurance cost for the vehicle for a year.

I have been unable to work my full part time hours due to my injuries and also need to pay off my credit card balance.

I attach my most recent credit card statements.

I will need an agreed order for the court to release the funds to either Lalit K. Jain, Esq. who will then distribute the funds to the proper parties and send a receipt of payment back to you and the Court or we can have the Court issue the funds directly to each party.

From your prior email it appears your only concern with releasing money to me was with Lalit, who you claimed was as a "random lawyer" (despite his decades long accounting and legal background) receiving all of the funds at once, so this appears to offer solutions to that concern.

Any funds saved in the purchase of the vehicle or insurance if sent to Lalit will be deposited in an interest bearing account for my use and managed by Mr. Jain for my benefit.

If we cannot get an agreed Order we will have to file for an Emergency Motion with the Court to determine if the funds can be released due to the damages it is causing me currently. If we do agree I will prepare an Agreed Order for your review to submit to the Court.

Please let me know ASAP your decision on this.

I am missing school and work due to these losses.

It is causing severe damages to me as a beneficiary of my grandparents.

Mr. Joshua Bernstein:

The court has set a hearing on your motion/petition; see attached. There is an issue because the terms of the trust do not allow all of the money to be sent to a random lawyer from New York, nor would any competent fiduciary recommend sending all of your trust funds to the person whose website includes the following: <http://www.lkjjesq.com/LKJESQ.pdf>.

As for the rest, if you wish to have a personal discussion of these issues, I am sure we can arrange a meeting with the Personal Representatives of your grandparents' estates and the successor trustee of their trusts. Your father and mother would not be welcome at such discussion. That is because your father has derailed and delayed these matters; squandered and wasted a substantial percentage (probably more

than half) of the estate's assets; refused to serve as trustee of your trust; and refused to accept distributions on your behalf, which were delayed for years and eventually deposited into the court upon order when no one would serve as successor trustee of your trust. If you wish to blame anyone, you will need to look no further than your immediate family as there lies the sole reason.

I do recall a vehicle owned by Simon was given to you by court order, without prejudice to that counting as part of any distribution to you or for your benefit. I would guess that is the car you totaled. One of the issues to discuss is how to account for that car as distributed to you back then, not in its current condition.

Also, I am curious what home you own. There is a home owned by Bernstein Family Realty, LLC, an LLC which at one time was owned by three trusts and which your father refused to accept on your behalf. Your uncle as Trustee was trying to protect the house and mortgage for your benefit and the benefit of all 10 grandchildren, but those attempts were hindered by persons, including Eliot Bernstein. We have serious concerns for the house, upon which the Simon Estate currently holds a large mortgage. If you wish to discuss BFR or the house, we welcome that opportunity.
