**PETITION FOR FEES AND COSTS OF
ATTORNEY FOR SUCCESSOR PERSONAL REPRESENTATIVE**

Ciklin Lubitz ("Petitioner"), counsel for Brian M. O'Connell, Esq., as Successor Personal Representative ("PR") of the referenced estate, by and through its undersigned counsel, herby submits this petition for an award of attorney's fees and costs ("Petition") for services to the PR and for the benefit to the estate of Simon L. Bernstein ("Estate"), and as grounds therefore, states as follows:

1. Brian M. O'Connell, Esq. was an attorney at Petitioner's firm until May 8, 2018. During this time, he was the PR for the Estate and was represented by Ashley Crispin Ackal, Esq., Clara Ciadella, Esq., Joielle Foglietta, Esq., and Zachary Rothman, each of whom were attorneys at Petitioner's firm.
2. The period covered by this petition for fees and costs is February 1, 2017 through May 8, 2018. Counsel for the PR has performed services and incurred costs as more fully described and set forth in the itemized schedule of services and expenses attached hereto as Exhibit "A".
3. Services provided to the PR by the Petitioner include, but are not limited to:
 - a. Represented the interests of the PR, the Estate and the Estate beneficiaries;

- b. Corresponded with the PR via telephone, email and in person meetings;
- c. Drafted numerous documents;
- d. Prepared for and attended depositions;
- e. Engaged in settlement discussions;
- f. Prepared for and attended mediation;
- g. Prepared for and attended various hearings, including but not limited to:
 - i. Various emergency motions;
 - ii. Motion to disqualify;
 - iii. Motion for order to show cause;
 - iv. Case management conferences;
 - v. Motion to specially sequence hearings;
 - vi. Petition for authorization to sell tangible personal property in bulk; and
 - vii. Motion to approve compromise settlement, appoint trustee for trusts, determine compensation of Guardian ad Litem, and for status conference to schedule additional hearings.
- h. Analyzed complex legal issues affecting the PR, the Estate and the Estate beneficiaries, including but not limited to:
 - i. Monitoring and analyzing developments in multiple appeals before Florida's Fourth District Court of Appeals;
 - ii. Invoking the discretionary jurisdiction of the Florida Supreme Court for consolidated appeals;
 - iii. Monitoring and analyzing developments in related Federal Court action in Chicago, Illinois;
 - iv. Contempt orders;
 - v. The payment of various taxes;
 - vi. Foreclosure issues;
 - vii. Injunctions; and
 - viii. Dispositive issues presented in motions for summary judgment.
- i. Delegated duties to paralegals, which reduced the costs of services;
- j. Accomplished other matters and provided significant other services as shown on the itemized billing records attached as Exhibit "A".

4. From February 1, 2017 through May 8, 2018, representatives of Ciklin Lubitz provided a total of 622.80 hours in services and at the rates described on Exhibit “A” attached. Ashley Crispin Ackal, Esq. provided 34.5 hours at \$350.00 per hour totaling \$12,075.00; Brian M. O’Connell, Esq. provided 18.7 hours at \$510.00 per hour totaling \$9,537.00, and 116.6 hours at \$475.00 per hour totaling \$55,385.00; Charlene A. Anderson provided 53.1 hours at \$160.00 per hour totaling \$8,496.00, and 263.9 hours at \$150 per hour totaling \$39,585; Clara C. Ciadella provided 7.0 hours at \$220 per hour totaling \$1,540.00, and 21.8 hours at \$200 per hour totaling \$4,360.00; Cynthia J. Thomas provided 1.8 hours at \$125.00 per hour totaling \$225.00; Joy A. Foglietta provided 25.1 hours at \$270 per hour totaling \$6,777.00, 70.8 hours at \$250.00 per hour totaling \$17,700.00, and 0.1 hours at \$0.00 totaling \$0.00; Paula M. Albright provided .4 hours at \$125 per hour totaling \$50.00; Summer D. Federer provided 1.8 hours at \$125 per hour totaling \$225.00; and Zachary M. Rothman provided 7.2 hours at \$185 per hour totaling \$1,332.00; for total fees of \$157,287.00. Costs are as itemized on Exhibit “A” attached and are \$11,011.04. Total fees and costs are \$168,298.04.
5. Due to a request made by Ted Bernstein, as Successor Trustee of the Simon Bernstein Trust, (“Trustee”) Petitioner has reduced its bill by \$35,254.38. Therefore, the total amount of attorney’s fees and costs sought through this Petition is \$133,043.66. The Trustee agrees to this amount.
6. Attorneys for a personal representative are entitled to reasonable compensation payable from estate assets. Fla. Stat. § 733.6171(1). Counsel’s services rendered to the PR and the Estate were both “ordinary” as well as “extraordinary” as defined in and contemplated by Florida Statutes, section 733.6171. The attorney’s services were

necessary for the proper administration of the Estate and to advance the interests of those persons interested in the Estate.

7. Attorney's fees should be awarded pursuant to Florida Statutes, section 733.6171 and other applicable law, including fees and costs in connection with proceedings initiated with this Petition, ("fees for fees"), as authorized by section 733.6175(2).
8. The applicable standard for determining an award of attorney's fees is set forth in Florida Patient's Compensation Fund v. Rowe, 472 So.2d 1145 (Fla. 1985). The case adopts the "Lodestar" method (hours reasonably expended multiplied by a reasonable hourly rate), as supplemented by Florida Statutes, section 733.6171(5)(a) – (i), and requires an analysis of certain factors. It is believed these factors are satisfied as described in this Petition and the time records attached.
9. Petitioner is providing this Petition to those persons on the following Certificate of Service.

WHEREFORE, Petitioner requests that this Court: determine Petitioner's reasonable attorney's fees and costs, including "fees for fees" for services initiated by these proceedings; direct the Restricted Depository to pay the amount awarded to Ciklin Lubitz from the assets of the Estate; and, award such other and further relief as the Court deems necessary and proper.


