***Zealous Attorney Rose's 06.28.2019 Personal Letter as a Legal Filing (E1-E3) Forced Beneficiary Eliot I Bernstein ("EIB") to File Super Silver Bullet Supplemental Support with no Defenses Reinforcing EIB's SilverBullet Cross Motion for Valid DOJ Granting Mandatory Restitution for Discretionary Destitution caused by All Void DOJs.***

With *all due respect* to the Court under *penalties of perjury*, **EIB's Super Silver Bullet Supplemental Support with no Defenses** reconfirms as follows:

1 Hon Court is *required* by Stop the Oppressive Prejudice ("STOP") against the injureds (EIB and his family members) *claiming Mandatory Restitution* and the *Silver Bullet LKJMOL with no defenses to silver bullet authorities* in endnotes<sup>1-10</sup> (A1-A6) with 10.31.2013 **NIELL (A1)**, Filing # 91601260 E-Filed 06.25.2019, to author, with authority, *Valid DOJs* granting **Mandatory Restitution**<sup>3</sup> for *discretionary destitution*<sup>6</sup> caused by *All Void DOJs authored, without authority, forced by zealous attorney Rose, still being paid by injurers to keep concealing the truth (A2), who demands continued concealing the truth by the Court too, knowing that:*
