
**ORDERED AND ADJUDGED** as follows:

To the extent that that the Motion is understood as a Motion to Appear Remotely, Via Zoom it is **DENIED**. The Defendant's own actions in violating the 15<sup>th</sup> Judicial Circuit, and this Court's, Orders not to record zoom proceedings caused this Court to enter a written order prohibiting zoom appearances for all parties in this matter.
