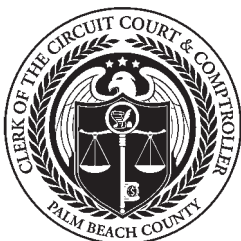

2. The Clerk is hereby directed to include the sum of \$9,293.58, representing property taxes paid by Plaintiff, in the calculation of costs due to Plaintiff in the foreclosure sale or in any redemption request.

4.
