**EMERGENCY MOTION TO RESET AND CONTINUE UMC HEARING
BY INTERESTED PERSON AND INTERVENOR ELIOT I. BERNSTEIN**

Comes now, Eliot I. Bernstein, an interested person and intervenor in this matter,
who respectfully moves this Court as follows:

1. I was previously entered as an Interested Person in this case with no objections filed by any party.
2. I am directly impacted by any Judgment or Order from this hearing seeking to hire Bradley Shraiberg to represent Pat Sahm, Sr in US Bankruptcy against me and such a result is also in bad faith by the Guardian Charles Revard as Mr. Shraiberg is implicated in fraud in the Bankruptcy Courts attempting to improperly represent Pat Sahm, Sr and it was only after I exposed this fraud in Bankruptcy in April of 2023 that this Guardianship was commenced 4 days later by Joanna Sahm who is also implicated in fraud in these proceedings.

3. This Court can refer to the initial Petitions in this case and the MH case for this information.
4. This matter is also not proper for a UMC Hearing which was only switched to UMC this past Friday according to the Docket and this matter should be continued until the fraud is sorted out and other actions in relation to this Guardianship are heard.
5. I am not sure how this was set by Kathryn Lewis for a UMC as she did not file the usual Certificate of Compliance with Rule 4 which is just one reason to Continue this hearing today.
6. A full evidentiary hearing is necessary on this motion and opposition to this action also in the best interests of Pat Sahm, Sr and to avoid further fraud in the proceedings.
7. It is hard to believe that my former attorney Inger Garcia Consented to this UMC but I believe she would have had to have done this for this to be set as a UMC but as the Court should know Ms. Garcia became implicated in Fraud on the Court by the Foreclosure Judge which created a conflict so she can no longer represent me but it is difficult to believe her client Patty Sahm, Jr. would consent to this UMC Hearing.
8. Ms. Garcia has previously told certain Courts including this one that there is fraud running across several cases and this includes in foreclosure and

Bankruptcy and specifically implicates Brad Shraiberg who falsely claimed to get a Retainer from Pat Sahm, Sr. in US Bankruptcy Court in a 2022 case with my sons by sending a Retainer to Sweetgrass Drive in North Carolina where Pat Sahm, Sr. never lived.

9. Ms. Garcia had pulled me out of this case to avoid a conflict allegedly over a year ago but now the case has even more conflicts that must be sorted out.
10. It is clear the original MH Petition and Guardian Petition was filed implicating myself and the company set up for my asset protection and family BFR, LLC.
11. Ms. Garcia had previously told my family she would be moving to correct fraud by Brad Shraiberg and Joanna Sahm in the Bankruptcy Court but for reasons I do not know this never happened.
12. In addition to the fraud alleged against Mr. Shraiberg in improperly representing Pat Sahm Sr. by a Retainer sent to Sweetgrass Drive in North Carolina, Mr. Shraiberg has direct conflicts against me as he also purported to represent one of my companies Iviewit.com LLC in an Involuntary US Bankruptcy against my company without ever seeking my Vote or approval as a Founder and Board Member of the Company back in 2001 and I only came to know this from a Warner Bros. contact who had found that my IP Inventions and Patents were placed into wrong names instead of my

companies where these patents were valued at hundreds of billions of dollars by leading experts at Lockheed Martin, the Intel Corp and other industry experts.

13. In fact as I told the US Bankruptcy Court I had been advised by Harry Moatz who at the time was the Director of the OED of the USPTO to file “fraud against the United States” charges which I did and Bradley Shraiberg is implicated in that and I still share and report information of my cases including this one to a DC contact.
14. Ms. Garcia had previously told my family she would be filing to Vacate the original Guardianship but for some reason this never happened either and I do not know why.
15. As the Court is aware there was no Fact finding or evidentiary hearing for the original Guardianship and Mr. Hall as Manager of BFR informed this Court about these facts which were disregarded.
16. Ms. Garcia had also informed my family she was going to support vacating Orders of Judge Burton after mandatory disqualification but for some reason had not done that either and I do not know why.
17. Instead Ms. Garcia allowed this Court and Mr. Revard who would not have had proper authority to proceed to a second MH Incapacity determination

which looks like On Consent by the Clerk's Notes but claimed she had filed evidence in that proceedings but this is not available.

18. There were many witnesses who could and should have been called in any incapacity hearing against Pat Sahm, Sr who appears as a victim of illegal guardianship by conflicted persons with financial motives.
19. My motives are clear. Walt and Pat Sahm, Sr were friends of my parents in business and did a friendly business deal to provide Asset Protection for me and my family after the Patents were stolen and my family minivan was Car Bombed.
20. I have tried to provide Pat Sahm, Sr with a reasonable settlement for years even though William Stansbury and Walt Sahm knew other monies in my parents Estates and Trusts were supposed to pay this off.
21. Instead the case has been mired in conflicts of attorneys seeking to bill the case instead of properly settle.
22. I am only seeking a Limited involvement in this matter and the proper adjudication of incapacity to protect Pat Sahm, Sr..
23. My former counsel Ms Garcia was also going to file exculpatory evidence to benefit Patty Sahm, Jr. from an improper Order on Vulnerable Adult exploitation and was going to correct that Order as the hearings were never completed but for reasons I do not know that did not happen either.

24. Ms. Garcia has said she has reported matters to the FBI and I believe the continuance is proper to sort these matters out not an improper UMC and reserve all rights to supplement this motion as justice requires.

WHEREFORE it is respectfully prayed for an Order continuing the UMC

Hearing for Brad Shraiberg to be hired and for such other and further relief as may be just and proper.
