**ORDER APPROVING APPOINTMENT OF JOSH BERNSTEIN AS
PRIMARY CO-TRUSTEE OF TRUST FUNDS HELD IN COURT**

REGISTRY, ADOPTING PRIOR MOTIONS, AND AUTHORIZING PARTIAL DISTRIBUTIONS

THIS MATTER came before the Court on the Motion filed by Josh Bernstein, a named beneficiary and nominee for Co-Trustee, seeking:

1. Approval of the unanimous consent of all beneficiaries and Co-Trustee Ginger Stanger to appoint Josh Bernstein as the **Lead and Primary Co-Trustee** over the Trust funds held in the Court Registry for the benefit of Josh, Jake, and Danny Bernstein;
2. Leave to **adopt and join in the prior Petitions and Motions** filed by Co-Trustee Ginger Stanger under Docket Entry Nos. 447 and 450 as if filed by Josh Bernstein himself;
3. Authorization for a **partial distribution in the amount of \$25,000** from the Court Registry to each of the three beneficiaries: Josh, Jake, and Danny Bernstein; and
4. Related relief, including participation by Zoom for certain parties, as set forth in the Motion.

The Court, having reviewed the Motion, the consents filed in support, the record in this matter, and noting the absence of any objection by any party with standing, and being otherwise fully advised in the premises, it is hereby:

ORDERED AND ADJUDGED:

1. The Motion is **GRANTED** in its entirety.
2. **Josh Bernstein is hereby appointed as Lead and Primary Co-Trustee** of the Trust funds currently held in the Court Registry on behalf of himself and his brothers, Jake and Danny Bernstein, to serve jointly with Co-Trustee Ginger Stanger.
3. Josh Bernstein is hereby authorized to **adopt and join in the Petitions and Motions** previously filed by Ginger Stanger under Docket Entry Nos. 447 and 450, and such adoption shall have the same legal force and effect as if those pleadings were filed by Josh Bernstein.

4. The Court hereby **authorizes partial distributions in the amount of \$25,000 each** to Josh Bernstein, Jake Bernstein, and Danny Bernstein, from the Court Registry funds held in Trust for their benefit. The Clerk shall process said distributions without delay.
5. The Court finds that **Co-Trustee Ginger Stanger** has consented to this motion in writing and is not required to appear live, though she may participate by Zoom as needed.
6. **Zoom participation is approved** for Ginger Stanger, Danny Bernstein, and Eliot Bernstein upon request, in accordance with the Division's remote appearance procedures.
7. This matter is deemed **resolved by consent** as to all parties with standing. No further objections will be entertained from parties who have disclaimed standing or filed statements of no objection.
8. The Court retains jurisdiction over this matter for enforcement and any additional necessary relief.
