**AMENDED ORDER APPROVING PARTIAL DISTRIBUTIONS OF  
REGISTRY FUNDS, RESIGNATION OF GINGER STANGER AND  
APPOINTMENT OF CANDICE BERNSTEIN AS CO-TRUSTEE**

**THIS MATTER** having come before the Court for hearing on December 2, 2025 upon the Petition of the Beneficiaries Joshua, Jacob and Daniel Bernstein for Agreed Orders with all Beneficiaries represented by Counsel Eric Cvelbar, all the Beneficiaries having been present on the Record, and the Petition and Notice of Hearing having been duly served upon all parties of record with or without standing, and Candice Bernstein having been present on the record, and the Court having made due inquiry of the parties and counsel and all beneficiaries being in unanimous consent and no other party with standing having objected, and being otherwise fully advised in the premises, **it is hereby**

**ORDERED AND ADJUDGED:**

1. The Petition is **GRANTED** in its entirety.
2. The resignation of Co-Trustee Ginger Stanger is accepted immediately and all duties and powers shall cease immediately and all Beneficiaries Joshua, Jacob and Daniel Bernstein having unanimously consented that Ginger Stanger is released and relieved of any and all liability for actions as Co-Trustee, Ginger Stanger is released from any and all liability as Co-Trustee;
3. That the appointment of Candice Bernstein having been unanimously consented to by each Beneficiary. Candice Bernstein is hereby appointed


Co-Trustee over the Registry Funds held in Trust and shall serve together with previously appointed primary and lead Co-Trustee Joshua Bernstein;

4. That Joshua and Jacob Bernstein being over the age of 25 and having exercised their right under the Trust terms and made age related distribution requests of 1 / 3 of their share of the remaining Trust Registry funds shall now each be paid an individual amount of \$22,620.48 each;
5. That lead Co-Trustee Joshua Bernstein having duly acted with broad authority specified in the Trust and having considered appropriate factors as allowed by the Trust an out of age equal distribution to Daniel Bernstein in the amount of \$22,620.48 being consented to by all Beneficiaries shall be distributed as if an Age 25 withdrawal was being made.

Consistent with prior practice **it is Ordered** that Joshua Bernstein is authorized to pick up the 3 individual checks to Joshua, Jacob and Daniel Bernstein in the amount of \$22,620.48 and in consideration of the history of the prior administration the Clerk is directed to administer and process the Distributions on an immediate and expedited basis.

The Court retains jurisdiction over this matter for enforcement and any additional necessary relief.
