A. Statement of Jurisdiction for the United States District Court.

The jurisdiction of the District Court is founded on Title VII of the Civil Rights Act of 1964 (42 U.S.C. §§ 2000e *et seq.*), 28 U.S.C. §§ 1331 and 1343. On August 15, 2014, Plaintiff-Appellant filed her pro se Complaint with the United

States District Court for the Northern District of Indiana. Jurisdiction was not disputed.

B. Statement of Jurisdiction for the United States Court of Appeals.

The jurisdiction of the United States Court of Appeals for the Seventh Circuit is brought under 28 U.S.C. § 1291, 28 U.S.C. §§ 2106-07 in that this is an appeal from a final decision of the United States District Court for the Northern District of Indiana seeking to reverse the Judgment of the District Court granting Summary Judgment on plaintiff's claim of discrimination in violation of 42 U.S.C. §§ 2000e *et seq.*, (Title VII), 28 U.S.C. §§ 1331 and 1343. The date of entry of the final judgment sought to be reviewed is March 4, 2015; the order granting summary judgment was entered March 3, 2015, both a United States District Judge. The appeal is from an order and final judgment that adjudicated all of the claims with respect to all parties, and no parties or issues remain in the District Court. Appellant did not file a motion for new trial or alteration of the judgment. The notice of Appeal was filed on April 2, 2015.
