Dear Judge Keever-Agrama:

I am counsel for Ted S. Bernstein, Successor Trustee of the Simon Bernstein Trust, which is the sole residuary beneficiary of the above-captioned estate.

On June 2, 2021, the Personal Representative filed a Petition for Discharge (DE 894, filed June 2, 2021), which included a waiver of accounting by Ted S. Bernstein, Trustee (DE 895, filed June 2, 2021). In the intervening one year and 19 days, there have been no objections filed to the Petition for Discharge. As reflected in the Petition, the Estate has been fully administered, and both independent actions filed in connection with this case have been dismissed, the last one by order of the circuit court more than one year ago, on March 9, 2021. A copy of that order is attached.

I have conferred with counsel for the Personal Representative, and have received from them a copy of their proposed and approved Order of Discharge, which is also attached. In light of the impending judicial rotations, while Your Honor remains in this division, and given the number of prior judges who have presided over this case, Ted S. Bernstein, Trustee, respectfully requests Your Honor enter the attached Order of Discharge as submitted by the Personal Representative, or schedule this matter for a hearing as soon as possible and before the impending judicial rotations.
