DIVISION "IA" (OTIA)**

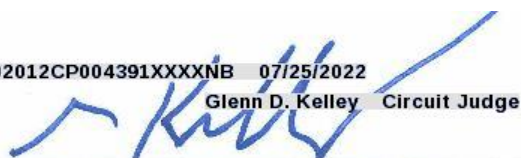
