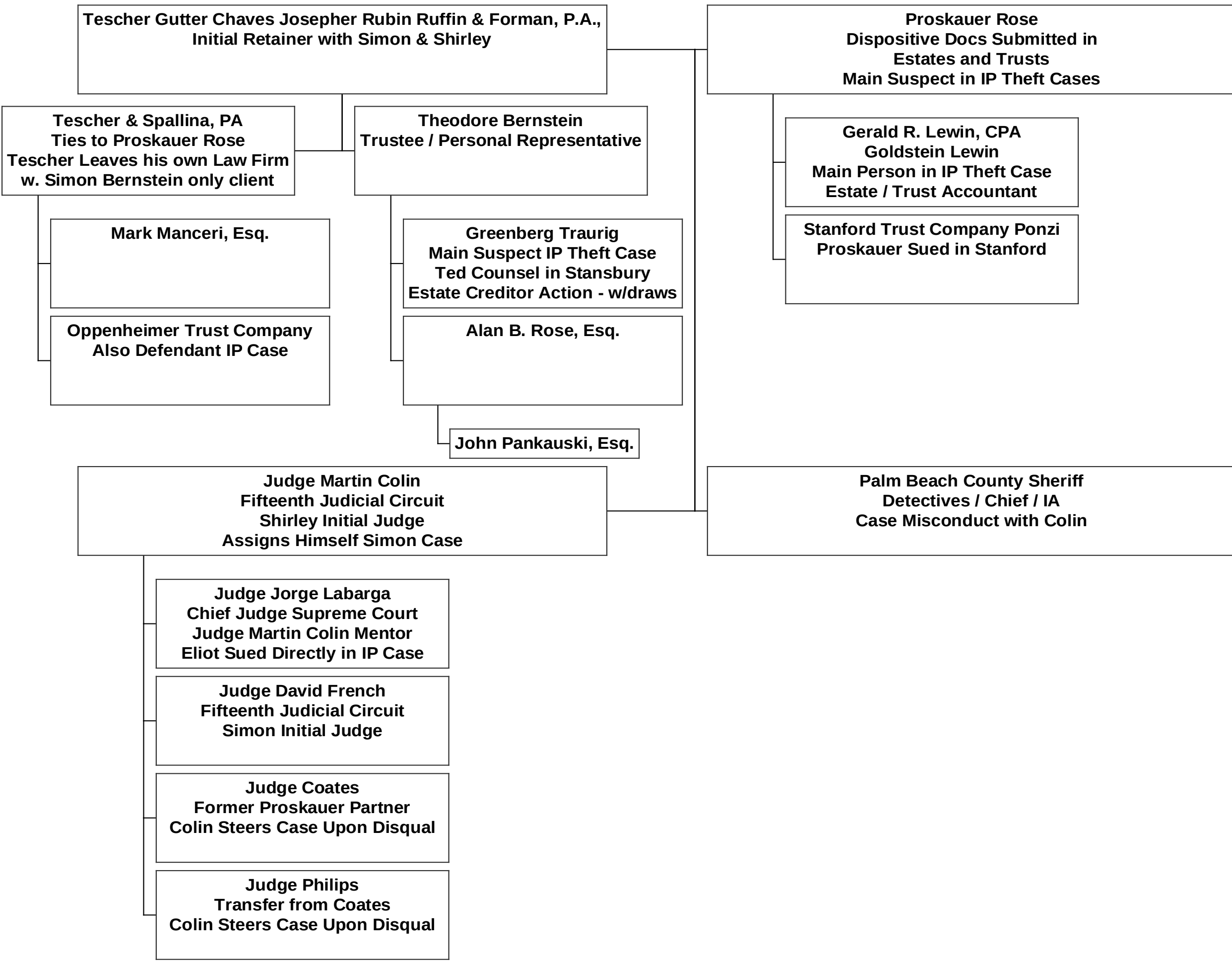


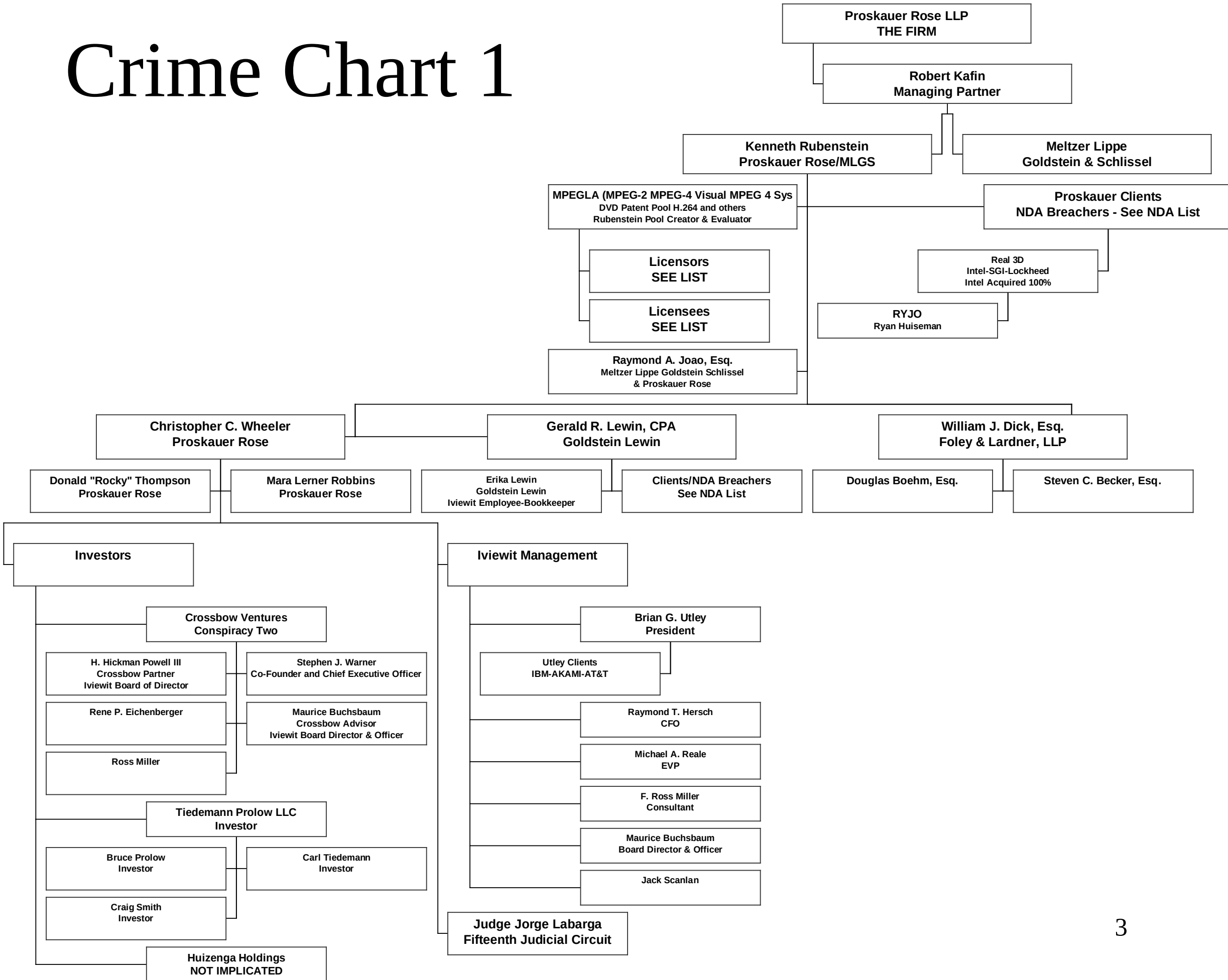

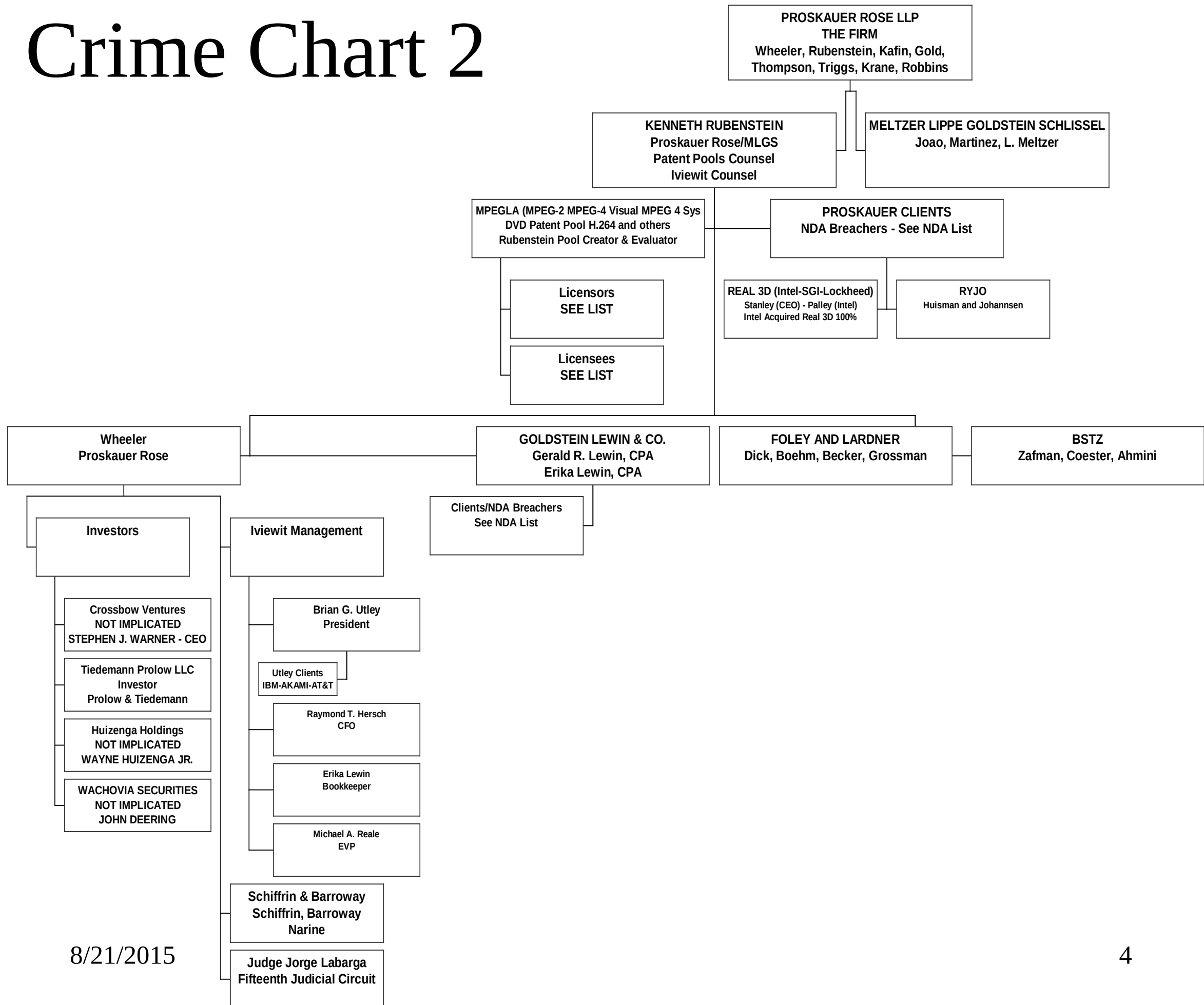
PROBATE - TRUSTS AND ESTATE CRIME CHART
