**ORDER DENYING SECOND VERIFIED SWORN PETITION AND AFFIDAVIT OF JULIA M.**  
**GONZALEZ FOR IMMEDIATE MANDATORY DISQUALIFICATION OF**  
**CIRCUIT JUDGE DAVID E. FRENCH**

THIS CAUSE submitted to the Court on June 29, 2016, the Second Verified Sworn Petition and Affidavit of Julia M. Gonzalez for Immediate Mandatory Disqualification of Circuit Judge David E. French, and the Court having carefully considered the Motion pursuant to Fla. R. Jud. Admin. 2.330(f), and being otherwise duly advised in the premises, finds:

1. Rule 2.330, Florida Rules of Judicial Administration, provides in relevant part:

The judge against whom an initial motion to disqualify under subdivision (d)(1) is directed shall determine only the legal sufficiency of the motion and shall not pass on the truth of the facts alleged. If the motion is legally sufficient, the judge shall immediately enter an order granting disqualification and proceed no further in the action. If any motion is legally insufficient, an order denying the motion shall immediately be entered. No other reason for denial shall be stated, and an order of denial shall not take issue with the motion.

2. The Court hereby determines only that the Motion is legally insufficient, *Pendelton v. State.*, 933 So.2d 1291 (Fla. 4<sup>th</sup> DCA 2006). Accordingly, it is, ORDERED AND ADJUDGED that the Motion is DENIED.
