Is your daughter Joanna available as we really would want her on the phone at the same time with you and can call you back if she is not available now.

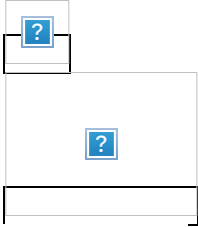
